**A RESOLUTION AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE A PETITION TO ANNEX LANDS INTO THE CITY OF NORTH LITTLE ROCK, ARKANSAS; AND FOR OTHER PURPOSES.**

WHEREAS, proposed petitioners, Galloway I-40 South Development LLC, an Arkansas limited liability, Land Trust of Arkansas, and City of North Little Rock, Arkansas (the "Proposed Petitioners"), being the sole owners of parcels of real property being contiguous to and adjoining the City of North Little Rock, Pulaski County, Arkansas, desire to petition to annex lands into the City of North Little Rock, Arkansas, pursuant to Arkansas Code Annotated § 14-40-609 (see Petition attached here to as Exhibit A); and

WHEREAS, the City of North Little Rock and the other Proposed Petitioners own parcels of real property adjacent to the City of North Little Rock (the "Property"), which the City of North Little Rock believes will be in the best interest of the City of North Little Rock, Arkansas.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH LITTLE ROCK, ARKANSAS:

SECTION 1: That the Mayor and City Clerk are hereby authorized to execute a Petition to Annex lands (see Petition attached hereto as Exhibit A and map attached hereto as Exhibit B) into the City of North Little Rock pursuant to Arkansas Code Annotated § 14-40-609.

SECTION 2: That the Mayor and City Clerk are hereby authorized to execute all other documents necessary to effect the completion of the herein stated annexation upon the terms set forth herein; with all such documents to be reviewed and approved by the City Attorney prior to execution.

SECTION 3: That this Resolution shall be in full force and effect from and after its passage and approval.
